

# Dayton Celtic Festival Merchandise Vendor

## Rules and Regulations

Vendor agrees to the following terms and conditions for participation:

1. The vendor will sell **only** the products listed on the application.
2. Vendor will occupy the space, and only that space, designated by United Irish of Dayton, Inc. and Five Rivers MetroParks, and operate from 6:00 PM to 11:00 PM on Friday, July 29, 2011; 12:00 PM to 11:00 PM on Saturday, July 30, 2011; and 10:00 AM to 6:00 PM Sunday, July 31, 2011.
3. Set up may begin at as early as 5:00 PM on Thursday, July 28, 2011, to ensure that vendor is set up and operational by 4:00 PM on Friday, July 29, 2011.
4. Vendor will remove all equipment, supplies and vehicles from the Dayton Celtic Festival area by 8:00 PM July 31, 2011. The vendor's space must be left clean with all trash placed in receptacles provided. Any trash that will not fit into the receptacles must be taken away and disposed of by the vendor.
5. Vendor will name United Irish of Dayton, Inc. and Five Rivers MetroParks as additional insured on the vendor's liability insurance policy for the event (Dayton Celtic Festival, July 29 – July 31, 2011), and must provide a certificate of insurance to United Irish of Dayton, Inc. and Five Rivers MetroParks by May 01, 2011, which documents this coverage. The policy should provide for a minimum of \$1,000,000 of liability coverage. Vendor will further indemnify and hold harmless from any and all loss, claims, demands, liability and actions in conjunction with this event and this agreement. Insurance forms need to be mailed to Beth Graham, 3115 Fowler Rd, Springfield, OH 45502.
6. Merchandise vendor will pay United Irish of Dayton, Inc. \$400.00 to rent a 10-foot by 10-foot space. For each additional space of 10-foot by 10-foot the vendor will incur an additional charge of \$400.00. All payments due and payable are to be made in the following manner:
  - Down Payment of ½ of unit space upon signing this agreement, due May 01, 2011
  - Remainder of payment is due no later than June 1, 2011
  - All payments to be made payable to: United Irish of Dayton, Inc.
  - The times for payments listed above are of the essence.
7. NO FOOD OR BEVERAGE WILL BE ALLOWED TO BE SOLD IN THE MERCHANDISE BOOTH
8. Five Rivers MetroParks prohibits camping and/or sleeping on festival grounds.
9. No political promotions, fund-raising, raffles, or games of chance are permitted.
10. You may not use any public address or other sound amplification system as part of your vending operation
11. You may not have any pets, other than guide/assistance dogs, on the Festival site.
12. The general appearance of the unit, equipment and employees will be a factor in the vendor's acceptance at future festivals.

13. Vendor's violating any terms of this contact or conduct contrary to the best interests of the Dayton Celtic Festival will not be permitted. Violators will be asked to remove their units and to leave the property and no fees will be refunded in such cases.
14. Celtic Festival times are expected to be:
  - Friday, July 29, 2011 from 6:00-11:00 PM
  - Saturday, July 30, 2011 from 12:00-11:00 PM
  - Sunday, July 31, 2011 from 10:00-6:00 PM
15. All merchandise vendors must have all booths open during these times, no early closures will be allowed.
16. It should be understood that this festival is held outside and all vendors are responsible for their tents. The vendor area is located on pavement and tents must be secured with sandbags or water barrels.
17. It is further agreed by and between the parties hereto that the vendor shall hold harmless the Celtic Festival, United Irish of Dayton, and Montgomery County Five Rivers Metro Parks from any actions, whatsoever by themselves, their agents or employees of the negligence of said persons. The Celtic Festival does not guarantee to insure vendor against damages, loss or injury, nor does it assume liability in case of damages, loss or injury. By signing this agreement the undersigned acknowledges that he/she read, understands, and will abide by the terms of this agreement.
